ADDENDUM NO. 1 CHANGES THE FOLLOWING:

MODIFICATIONS – DRAWINGS

1. Sheet 3 of 26, Add note, “All concrete trail shall include reinforcement with #4 rebar @ 2’ O.C. or equivalent as approved by Engineer.”
2. Sheet 4 of 26, Change Quantity Item 9 from “10’ Trail Concrete Pavement” to “8’ Trail Concrete Pavement”.

CLARIFICATIONS

1. The sign-in sheet for the Optional Pre-Bid meeting is attached to this Addendum.
2. The Contractor is responsible for all permits and materials testing.
3. Benesch will have part-time on-site construction observance services over the duration of the project.
4. There are no WBE/MBE requirements. Refer to the Good Faith Outreach Manual.
5. This project is ARPA funded. All funds must be encumbered by December 31, 2024.
6. Construction will begin in Spring 2025 with ninety (90) calendar days for project completion.
7. This project will bid an 8-foot wide trail. Any extended width will be at the expense of the contractor.
