The Unified Government of Wyandotte County/Kansas City, Kansas hereby provides Offerors with answers to written questions for Bid B42992. Respondents must deliver their Addendum 1 with their bid **May 6, 2026, at 8:45 a.m. Central Daylight Time (CDT) in the Clerk's Office located on Floor 3, Room 323.**

Question 1: Would the county be open to a different body make than Century? Would Jerr-Dan be sufficient? We can call out the differences for the specs.

**Answer: Our preference for the body make is Century, but offerors may list their alternate on the "Unit Cost Alternate Bid Per Vehicle" line on the Attachment B Bid Sheet.**

Question 2: Is there a preference for a specific make of chassis?

**Answer: Our preference is a 2026 Kenworth T880 for the chassis.**

Question 3: When does the completed vehicle need to be in the County's hands for use?

**Answer: Before winter.**

Question 4: Can a vendor submit multiple bids?

**Answer: Offerors may have one submission. Within that submission, offerors may have their primary bid and an alternate bid. If an offeror has more than two options, please write it on the Attachment B Bid Sheet.**

Question 5: As an alternate bid, would a 2024 model year chassis (Western Star) be acceptable for submission as long as it was attached to a 50-ton wrecker body?

**Answer: Unfortunately, we can't give specific guidance on what information or products you should put in your submission. Alternate bids are at the offeror's discretion and whether the offeror wants to provide another option or not.**
