The Purchasing Division must inform you of the following:

1. **Section 4.2 of the RFQ requires that the appendices be a part of the 30-page limit for the proposal submission. Appendix A is the financial statement. Our baseline financial statement is 19 pages of information. Can you please clarify what information is required in the financial statement section, so that we can reduce the number of pages for this section by removing any unwanted information or could the appendices possibly be submitted as a separate attachment and not in the 30-page limit?**

The appendices will not count toward page count, and the page count will remain at 30 pages total.

2. **On page 6, section 4.2 Format of the Submittals - Phase I shall require all firms to submit an SOQ of a maximum of thirty (30) pages, including appendices, to include the following information. The appendices that are listed on the following page table that sets the specific items to be addressed in the SOQ, states that the appendices include financial statements and bonding capacity. I wanted to clarify that all pages of the firm's financial statements and bonding capacity count against the 30-page count?**

3. **On page 6, section 4.2 Format of the Submittals - Phase I shall require all firms to submit an SOQ of a maximum of thirty (30) pages, including appendices, to include the following information, bullet #4 Experience in this type of project delivery system; On the following page table that sets the specific items to be addressed in the SOQ, the bullet is not listed. Is this a sub bullet of the Project Experience or should it be it's own section?**

Experience in this type of project delivery system (CMAR) shall be included under Project Experience section of the SOQ.

4. **Signature Page “Attachment A” and Debarment page “Attachment B” are not listed in the table. Do these attachments need to be included in the 13 copies or just the original? If they are included in every copy would you like them to be included following the appendices? Do they also count against the 30 page count?**

- Do these attachments need to be included in the 13 copies or just the original?
 - Signature Page “Attachment A” and Debarment page “Attachment B” are required only in the original.
- If they are included in every copy would you like them to be included following the appendices?
 - See above response.
- Do they also count against the 30-page count?
 - No.

5. **Are there self-performance criteria?**

The CM will be allowed to self-perform any work package given that a bid is submitted 24 hours prior to the time bids are due for equipment vendors and subcontractors. All CM self-performance bids will be received by UG Purchasing Department 24-hours prior, while all remaining equipment vendors and subcontractor’s bids will be received by the CM at the time bids are due.
