THE ABOVE-MENTIONED REQUEST FOR PROPOSAL IS HEREBY AMENDED AS FOLLOWS:

Addendum 1

The Unified Government of Wyandotte County hereby provides Offerors with questions/answers and clarifications regarding RFP R41390 Tow Services. Respondents must deliver their Addendum 2 with their response/proposal **May 1, 2025, at 2:00 p.m. Central Daylight Time (CDT)**.

Question 1: Reference page 23, paragraph 2. If an offeror plans to submit a proposal for both zones, do they have to have a lot in each zone?

Answer 1: No. The Offeror may have a lot at any location, provided it's within Wyandotte County and the Offeror can meet the required response times.

Question 2: Reference page 22, Section 6.01b Scope of Work. Do both acres have to be part of the same lot?

Answer 2: No. The minimum requirement of 2-acres may be divided into multiple lots provided all lots are located in Wyandotte County.

Question 3: Reference page 24, Section 6.02 Deliverables 6.0a. FUSUS has been difficult to reach for assistance in ensuring that our current technology is able to integrate with FUSUS. Is there someone we can contact to check the compatibility of our system with FUSUS?

Answer 3: Call Captain Fithian at 913-488-1318.

Question 4: Would you consider covering the cost of towing vehicles to and from the new CSI facility and the towing company's lot for crime victims?

Answer 4: Offerors may include the cost in their proposal to account for services provided without collecting fees from crime victims.

Clarification 1: Reference page 25, Section 6.02 #13 Performance Standards. Towing of more than one (1) vehicle with each wrecker at one time shall be prohibited. When more than one (1) wrecker is ordered, the number of wreckers ordered shall respond.

Addition 1: Rollbacks may safely tow two (2) vehicles.
