The Purchasing Division must inform you of the following:

1. How many times was the previous vendor called out to do a pickup from illegally dumped material in 2024? **We just recently began urging the departments to dispose of their hazardous waste and not use the residential events to do so. So, we have only had this happen one time in 2025, but we expect this to occur more often going forward.**

Can we get a list and address of UG Departments that may need pickups?
Are they all CESQC? What is their Generator Status? **They are not CESQC.**

2. How many events are scheduled for 2026? How many cars usually attend these events? **We have 7 events scheduled each year. They are every 3rd Saturday of the month beginning in April and ending in October. The only exception in 2026 is in June and it will be held on the 13th since UG/KCK recognizes Juneteenth (June 19) as a holiday and 3-day weekend. The events are from 8:30am-1:00pm. We average around 150 cars.**
3. UG lists Recycling, Fuel blending then incineration as your preferred treatment methods, but it appears your largest stream (latex paint) was landfilled. Is that still your preferred method? **Yes, but we are open to whatever is safe, efficient and inexpensive.**

5. Where is the illegally dumped waste taken once it is picked up? Or are we expected to pick it up and have it profiled from the dump site? **We would prefer it to be picked up from the dump site since we aren't always sure what it contains.**
6. Are the lead acid batteries picked up from your HHW permanent site by wholesale batteries, or do we take the batteries to wholesale batteries? **UG is responsible for taking them the Wholesale Batteries.**
